> 9. CURRENCY CONVERSION FEES

- Standard currency changes are executed daily, at about 4pm, at the current exchange rate (Interbank exchange rate + 0.60%).
- A preferential rate (Interbank exchange rate + 0.30%) applies for change operations exceeding CHF 50'000 (or equivalent).
- Real time exchange conversion on demand (from CHF 100'000 or equivalent).

> 10. OTHER GENERAL INFORMATION

- There is no surcharge for partial executions of share trade executions on the same or even on subsequent days.
- The prices do not include the federal stamp duty or any foreign stamp duties and stock market fees or VAT that may apply.
- Securities that cannot be traded online and off-exchange operations are subject to special fees.
- Other costs and conditions may apply for clients whose assets are managed by an independent asset manager. If these costs and conditions are not explained in the contract that has been entered into with their asset manager, they have to contact their asset manager or Strateo in order to find out which costs and conditions apply to their account.
- Custody fees are spent on a quarterly basis based on a daily valuation of the total portfolio value.
